- 1) The Photo Model herewith consents to the use of the above-specified photographs depicting him/her (photographs of the Photo Model) in all forms of publication (print media, Internet) as well as in broadcast transmissions. These photographs will be employed exclusively for the non-commercial purpose of promoting the image of ALP at JGU internally and externally.
- 2) The Photo Model specifically consents to the use of the photographs in unedited and edited form by the Client without restrictions of any sort in terms of content, time, geography, or design. There shall be no restrictions on the scope of use of these photographs; they may be used in connection with both existing and future analog and digital applications and systems, including print media, television via all broadcast channels, the Internet, mobile devices, social networks and messenger services, image databases (online/offline), the intranet, digital newsletters, CDs, DVDs, Blu-ray Discs, and other storage media.
- 3) The Photo Model also consents to the use of his/her photographs within montages in which these are used in combination with other images, texts, or graphics as well as within photo montages in which parts of the original photograph(s) are removed or supplemented and/or alienated or re-colored.
- 4) The Photo Model shall not retain the right to demand the use of the photographs as defined above. Should the photographs not be utilized, the Photo Model shall not have the right to withdraw this consent or any other form of

consent. The Photo Model does not have the right to disclosure of information on the scope of the actual usage of the photographs.

- 5) The Photo Model herewith transfers all the rights necessary for specified utilization of the photographs taken at events of the Ada Lovelace Project to the Client.
- 6) The Client or a third party shall decide at their discretion whether to reveal or not reveal the name of the Photo Model.
- 7) No employment relationship shall result from this agreement.
- 8) The Photo Model shall not be entitled to the payment of a fee by the Client.
- 9) The Photo Model herewith confirms that he/she owns all rights (including brand rights and other rights) required for the utilization of the photographs of his/her person or his/her property and herewith releases the Client from liability for all third-party claims that may be lodged in this connection.
- 10) No ancillary oral agreements have been made. All amendments to this agreement must be made in written form or will otherwise be considered invalid.
